Fishtech Global's system for quarantine of freshwater and saltwater fish was developed over 17 years with more than 10 000 hours of research. This involved culturing the protozoans to understand their lifecycle and monitor how medications affected them, while viewing the results under our microscopes in our laboratory.

The medications were then applied to over 300 species of fish and the results for each experiment were recorded and adjusted for all internal and external diseases in freshwater and saltwater aquarium fish.

Our system only uses medications that can be easily accessed and safe to use for all the employees in your aquarium store. The system is divided into 2 stages to prevent harm to the biological filters operation. When using our system the public will be unaware of the first and second stages of medicating.



Over the 17 years of research our team found the results surpassed all our expectations for high quality, healthy aquarium fish in a commercial situation. Many species of aquarium fish that are often considered difficult to keep, actually hosted protozoans in the mucus composition and usually resulted in high mortalities .

Other fish that are sensitive to medication have a different mucus composition to fish species that are very resistant to medications.

This resulted in dividing the fish species into colour codes for the first and second stage of quarantine procedures. The entire system is extraordinarily complex at this stage.

Anyone can follow the procedures, as the sheets are easy to read with clear instructions.

How does our system work?

Fishtech Global organizes the quarantine and disease management of all aquarium fish in your store. We will send you daily emails with the initial quarantine of your new fish and medicating instructions for your retail display aquariums.

Your store will have its own database in our computer program with all your aquarium codes and species housed in your aquariums.

When new shipments of freshwater or saltwater aquarium fish are due to arrive, let us know beforehand via email and we will send you the “new arrivals” form and a list of codes and species for you to update. This is then returned to us to enter into our disease management program.

Our daily sheets we send to your business are easy to follow by any of your team members. Every day we will walk you through the quarantine of the fish and medicating of the aquariums as well as preparing medicated food.

Your customers will not notice your aquariums are being medicated, but they will notice how healthy your fish look.

What is the next step to disease free fish?

Fishtech Global requires all your aquariums to be coded as well as water volume of each aquarium. The codes must represent stand alone filtration or interconnected filtration. E.g. the codes for 3 stand alone aquariums would be say Tr06, Tr07, Tr08. If these aquariums were interconnected, the codes would be TR06a, Tr06b and Tr06c. This lets us know these aquariums share the same filtration and water circulation. This will assist us in calculating medications required during quarantine.

We also require a list of the species housed in the aquariums such as Tropical fish, Goldfish, Scaleless fish and Cichlids. Our form we provide will give you more information on the list of fish species we require.

Once we have this information we will setup your customized program in our system.

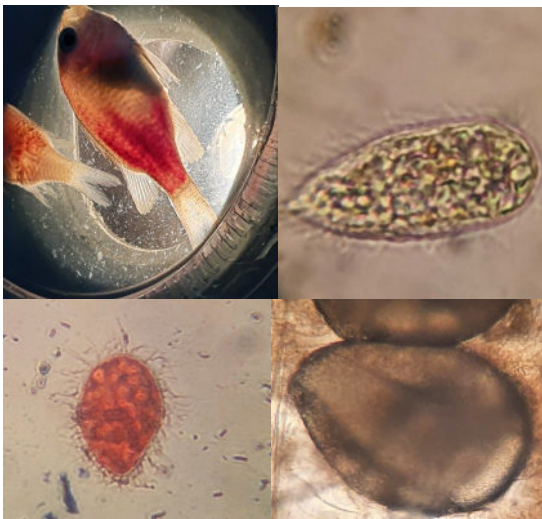
Why should I consider Fishtech Global's fish disease management system in my business?

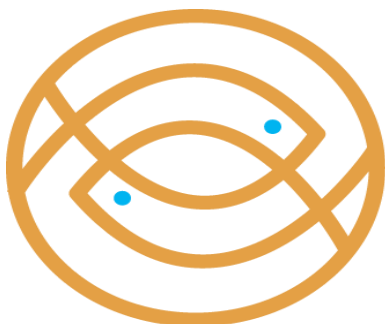

What equipment do I need to quarantine all the fish?

Fishtech Global has created the most effective aquarium fish disease management system, over a 17 year period. The system can be simplified to replicated by any aquarium store. Below we have a list of the equipment you require to implement our system and procedures.

All of the equipment is easily purchased through various vendors or can be purchased from Fishtech Global website.



Containers connected to airpumps

Compulsory Equipment

- 500ml takeaway containers (Betta QT)
- 150ml takeaway containers (medicated food)
- 5 litre Storage boxes (low stock QT)
- 10 litre Storage boxes (Medium stock QT)
- 15litre Storage boxes (high stock QT)
- Air pumps
- Air stones setup in gangs of 2,3,4.
- Disposable gloves
- 5ml, 10ml Syringes
- Small measuring cups 30 –50ml
- 1 Teaspoon measure
- 1/4 Measure teaspoon
- Eye droppers
- Countdown timer
- Stopwatch
- Scales to weigh to 100th of a gram

Safety equipment

- Lab coat.
- Mask/Respirator
- Sleeves
- Safety Glasses
- Chemical storage cupboard (lockable)

Optional equipment

- Chemical spill tray

What are the medications used in the Fishtech global system?

Medications and Chemicals used in Fishtech Global's procedures, are very simple to use and very easy to obtain. We only use Chemicals and medications that are easy for you to purchase. The medications are measured precisely by our computer algorithm to take the guess work out of administering medications for your aquariums.

Fishtech Global requires very accurate listing of your aquariums designated codes and water volume in each aquarium. Interconnected aquariums must be listed with a suffix of a, b, c etc. after the main code number.

Some chemicals are used together to increase effectiveness.

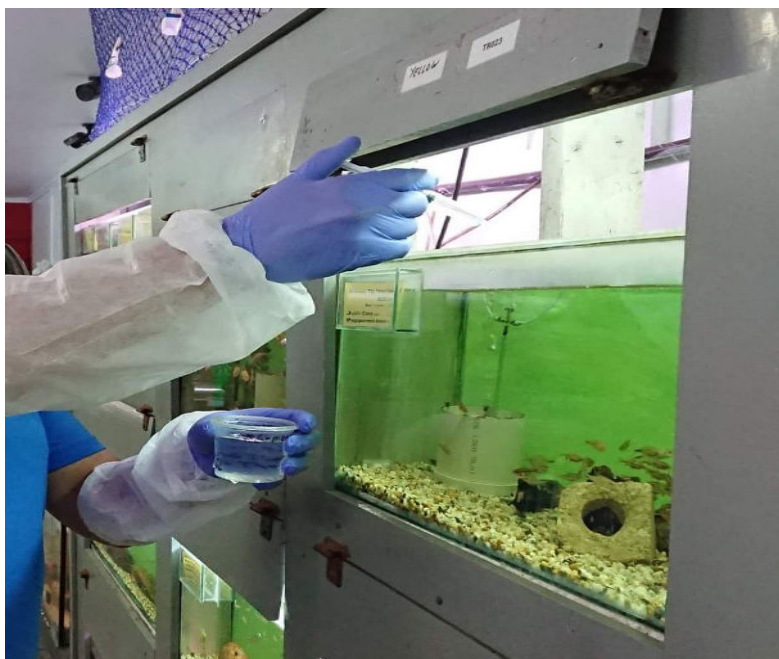

The medications listed are used in the first stage and second stage of quarantine both in the containers and the aquariums

Freshwater fish are quarantined for 6 days and Marine fish are quarantined for 12 days. The medications are dosed daily and fish are fed medicated food before being placed into the aquariums.

The second stage quarantine commences for the next 2 to 3 weeks. Fish can be confidently sold during this time .

With multiple shipments under quarantine during any given period, our daily emails will guide you easily with step by step checklists.

Why do I need an email everyday to quarantine and medicate the fish?

Why do I need an email everyday? Fishtech Global's system may seem simple in the initial stage but once the next shipment of fish arrive the system resets for the aquariums that the new fish go into. Then as species are mixed together and changes occur the system needs to constantly adjust. This is our job.

Also ,as our continuing research updates the algorithm that runs the procedures, your emails will reflect these updates without disruption to your routine. We've done the hard yards and will continue to do so.
